1 Respective responsibilities of the body and the auditor

2 External auditor report 2018/19

Except for the matters reported below, on the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with Proper Practices and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

The AGAR was not accurately completed before submission for review. Please ensure that amendments are corrected in the prior year comparatives when completing next year's AGAR:

- Section 2, Box 10 is inconsistent with the balance published by the Public Works Loan. The figure in Box 10 should read £5,336.
- The figures in Section 2, Boxes 9 and 10 of the prior year comparative column are incorrect due to a transcription error and should read £534, 970 and £6,320 respectively.

Other matters not affecting our opinion which we draw to the attention of the authority:
